"SEXUAL HARRASSMENT COMMITTEE" FOR WOMEN/GIRL STUDENTS

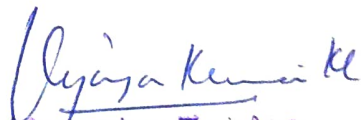
Affiliation bye laws prescribes to constitute Sexual Harassment Committee to safe guard the girl students from harassment. Thus a committee is constituted as below:

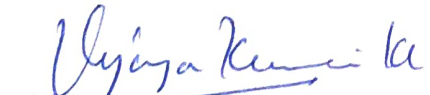
POCSO COMMITTEE

All children have an equal right to access education in an environment that is safe, protective and conducive to overall development. The challenges of gender inequality, eve-teasing and sexual abuse in school environment call for increased awareness and creating synergy among parents, teachers and school. In order to ensure strict compliance of the Protection of Children from Sexual Offences Committee (POCSO) Act 2012, CBSE has taken several initiatives and actions for creating awareness about sexual exploitation among school children.

To safeguard the interests of the learners, **SHREERAM PUBLIC SCHOOL** has set up the POCSO Committee (under the provisions of Prevention of Children from Sexual Offence Act 2012) on 13 April 2026. The committee will take appropriate and necessary action on reported cases of misbehaviour or sexual offences in the school premises. The Committee takes up age-appropriate initiatives to create awareness about sexual exploitation and to ensure that all learners are aware of their rights and responsibilities towards themselves. Training sessions are conducted for the faculty and staff to recognize and report issues of abuse and neglect. Complaint boxes are placed strategically and checked regularly by the Committee members to address the complaints, if any. Through its awareness campaigns and programmes, the Committee strives to ensure that all learners are treated with dignity and respect at all times. Gender Sensitivity Awareness programmes are conducted for learners. In a series of Awareness programmes and Special School Assembly conducted in the school throughout the year, learner participation is encouraged. Age-appropriate videos are shown and self-defence sessions are also conducted as a part of the Awareness Programmes.
